A BILL to authorize and empower Harford County, Maryland to borrow, on its full faith and credit, and issue and sell its bonds or other evidences of indebtedness (including lease financing), in an amount not to exceed Five Hundred Thirty Thousand Dollars (\$530,000.00) principal amount, the proceeds thereof to be used for the expansion, reconstruction, rehabilitation, renovation and improvement of certain water and sewer projects as described in the Annual Budget and Appropriation Ordinance, Bill No. 19-012, as amended, for the year ending June 30, 2020 and as described in this Bill in accordance with Section 524 of the Charter of Harford County and Sections 123-40 and 256-26 of the Code of Harford County or as otherwise permitted by law; authorizing the County Council of Harford County, Maryland (the "County Council") to adopt an administrative resolution that shall provide for the form of instrument by which any indebtedness is to be evidenced, the manner by which bonds and any other indebtedness may be secured and the rate(s) of interest to be paid, and generally for such other matters as may be deemed appropriate by the County Council in connection therewith and authorizing the County Council by administrative resolution or the County Executive of Harford County, Maryland (the "County Executive") by executive order to determine the form of various documents as are necessary or desirable to implement the financing authorized herein, the manner of issuance and delivery of any bonds or any other evidences of indebtedness, the payment of all necessary expenses in connection therewith, the method by which bonds or any other evidences of indebtedness shall be sold, maturity schedule, and redemption provisions; authorizing the appointment of certain agents, and otherwise generally relating to the issuance, sale, delivery and payment of bonds or any other evidences of indebtedness; providing that bonds or any other indebtedness shall be issued upon the full faith and credit and taxing power of Harford County, Maryland; providing for the issuance of bond anticipation notes (or other form of indebtedness) upon adoption of an administrative resolution by the County Council approving the interest rate or rates to be borne thereby for all or a portion of the projects described herein, for which the proceeds of sale of the bond anticipation notes shall be used; providing that after the issuance of the bond anticipation notes (or other form of indebtedness), or any renewal thereof, the County Council shall authorize the issuance of bonds to pay said bond anticipation notes (or other form of indebtedness); providing that upon written recommendation of the County Executive and administrative resolution of the County Council, all or a portion of the indebtedness authorized herein may be incurred pursuant to loans from the Maryland Water Quality Financing Administration;

1 providing for disbursement of the proceeds of the sale of bonds or other indebtedness
2 authorized herein and for the levying of charges, assessments and all taxes necessary to
3 provide payment of the principal of and premium (if any) and interest on bonds or
4 other form of indebtedness; providing that certain additional matters may be
5 determined by resolution of the County Council or may be reserved unto the County
6 Executive as prescribed by such resolution; providing the method of fixing the interest
7 rates to be borne by such bonds and generally providing for and determining various
8 matters in connection therewith; and generally relating to funding of the projects
9 described herein.

1 WHEREAS, among other State of Maryland and local laws, Section 524 of the Charter of
2 Harford County, Maryland (the “Charter”) and Sections 123-40 and 256-26 of the County Code
3 of Harford County, Maryland (the “Code”) authorize Harford County, Maryland (the “County”)
4 to incur long-term indebtedness; and;

5 WHEREAS, in accordance with the provisions of Section 406 of the Charter, the Director
6 of Planning has heretofore transmitted to the County Executive of Harford County, Maryland
7 (the “County Executive”) the recommendations of the Planning and Advisory Board for certain
8 capital improvements; and

9 WHEREAS, in accordance with the provisions of Section 505 of the Charter, the County
10 Executive has reviewed such recommendations in light of the existing capital programs and the
11 County Executive and the Director of Administration of the County (the “Director of
12 Administration”) have included such recommendations for capital improvements, as may be
13 amended, in the proposed Capital Program that has been submitted to the County Council of
14 Harford County, Maryland (the “County Council”) and the County Council, after written
15 recommendation of the County Executive, public hearing and affirmative vote of at least four (4)
16 members of the County Council, has adopted the Capital Program (the “Capital Program”) and
17 Capital Budget (the “Capital Budget”) for the year ending June 30, 2020, pursuant to Bill No. 19-
18 012; and

19 WHEREAS, upon request of the County Executive and resolution of the County Council,
20 the County may sell bond anticipation notes in an amount not greater than the amount of bonds
21 authorized herein, in anticipation of the subsequent sale of the bonds, for all or a portion of the
22 cost of the Projects (defined herein) in accordance with the provisions of Sections 19-211

1 through 9-221 of the Local Government Article of the Annotated Code of Maryland (2013
2 Replacement Volume and 2018 Supplement); and

3 WHEREAS, as a part of the Capital Program and the Capital Budget, it is necessary that
4 the County borrow a sum not exceeding Five Hundred Thirty Thousand Dollars (\$530,000.00) to
5 be used to finance the cost of the acquisition, construction, reconstruction, improvement,
6 extension, site acquisition, architectural and engineering services, and furnishings and equipment
7 for the Projects, including financial, legal and planning expenses related thereto; and

8 WHEREAS, Section 520 of the Charter requires that the County Council authorize the
9 indebtedness described herein by legislative act and Section 524 of the Charter and other
10 applicable provisions of law provide for the incurrence of indebtedness on the faith and credit of
11 the County and the annual levy of *ad valorem* taxes upon the assessable property within the
12 County sufficient, together with other taxes and other available funds, to provide for the payment
13 of the principal of, premium (if any) and interest on any bonds or other indebtedness issued by
14 the County hereunder; and

15 WHEREAS, the proposed bonds or other indebtedness is within the legal limitation on
16 the indebtedness of the County; and

17 WHEREAS, it is necessary to provide funds for the construction, reconstruction,
18 improvement, extension, acquisition, alteration, repair and modernization, the cost of acquiring
19 any sites, making site improvements, architectural and engineering services, including
20 preparation of plans, drawings and specifications, the development of the grounds and
21 landscaping thereof, financial, legal and planning expenses and all customary appurtenances and
22 equipment for the Projects; and

1 WHEREAS, the financing or indebtedness herein authorized, including the aggregate
2 principal amount of bonds or other indebtedness in an amount not to exceed Five Hundred Thirty
3 Thousand Dollars (\$530,000.00), and interest rate(s) to be borne thereby, shall be evidenced and
4 incurred pursuant to an administrative resolution to be adopted by the County Council upon
5 written recommendation of the County Executive, pursuant to this Bill and other terms of sale,
6 including, but not limited to maturity schedules, redemption provisions, form of bond, and date
7 of sale shall be determined by administrative resolution of the County Council or executive order
8 of the County Executive, as hereinafter set forth.

9 NOW, THEREFORE, IN ACCORDANCE WITH THE PROVISIONS OF THE
10 CHARTER, THE CODE AND THE LAWS OF THE STATE OF MARYLAND:

11 **SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF HARFORD**
12 **COUNTY, MARYLAND** that, acting pursuant to the authority of the Charter, the Code and the
13 laws of the State of Maryland, Harford County, Maryland (the “County”) hereby authorizes and
14 approves the incurrence of debt or the payment of purchase price or rental installments for the
15 purpose of financing all or a portion of the cost of capital equipment, improvements, extensions,
16 modifications, alterations, or any combination thereof to the property of the County, together
17 with the acquisition of all necessary property rights, and all related architectural, financial, legal,
18 planning, design and engineering expenses associated with such capital equipment,
19 improvements, extensions, modifications or alterations for the following:

21 All of the above are herein collectively referred to as the “Projects.”

1 The principal amount of indebtedness to be incurred hereunder shall not exceed Five
2 Hundred Thirty Thousand Dollars (\$530,000.00).

3 **SECTION 2. AND BE IT FURTHER ENACTED BY THE COUNTY COUNCIL**
4 **OF HARFORD COUNTY, MARYLAND** that prior to the issuance, sale and delivery of any
5 bonds or other evidences of indebtedness in reliance on this Bill, the County Council shall
6 (without limitation) determine by administrative resolution:

7 (a) the form of instruments and agreements by which the debt authorized
8 herein shall be evidenced (including, but not limited to, bonds, bond anticipation notes, notes or
9 other form of indebtedness, book entry, community participation bonds, letters of credit, trust
10 agreements, trust indentures, financing or installment purchase lease or similar financing
11 agreement, or participation in any “bond bank” or bond pooling arrangement administered by the
12 State of Maryland or a subsidiary entity of it);

13 (b) the manner, if any, by which any indebtedness shall be secured (including,
14 but not limited to, a pledge of the revenues from the County’s water and sewer system or any
15 other appropriate revenue stream, a letter or letters of credit, bond or other such insurance and a
16 pledge of the full faith and credit and unlimited taxing power of the County):

17 (c) the rate or rates of interest or method of determining such rate or rates; and

18 (d) whether the financing is to be accomplished by public sale, private
19 (negotiated) sale or by private placement.

20 Any resolution adopted by the County Council under, pursuant to or in accordance with
21 this Bill shall be deemed to be of an administrative nature and shall be effective upon the date
22 specified therein.

1 **SECTION 3. AND BE IT FURTHER ENACTED BY THE COUNTY COUNCIL**
2 **OF HARFORD COUNTY, MARYLAND** that the County Council shall also by administrative
3 resolution determine the following matters:

4 (a) the principal amounts, date, denominations, interest payment dates,
5 maturity payment provisions and prepayment, tender and/or redemption provisions (if any) and
6 other terms and conditions thereof;

7 (b) the substantially final form and contents and consent to the distribution
8 (and shall authorize the execution and delivery, where applicable) of various agreements and
9 documents as are necessary to incur the indebtedness authorized herein, including, but not
10 limited to, a Preliminary Official Statement and/or an Official Statement, and in the event any
11 evidence of indebtedness is sold through competitive bidding, a Notice of Sale, and in the event
12 any evidence of indebtedness is sold by private (negotiated) sale, a Purchase Contract with the
13 underwriter(s) thereof, and if any indebtedness is issued in book entry form, securities depository
14 agreements (collectively the “Documents”) required for the issuance, sale and delivery of any
15 evidence of indebtedness authorized herein, which Documents shall contain such provisions as
16 may be required by law or determined by the County Council to consummate the financing
17 authorized herein;

18 (c) the manner in which any evidence of indebtedness shall be executed,
19 sealed and attested (which may be by facsimile signature and/or seal);

20 (d) provision for the payment of all necessary expenses of preparing, printing
21 and selling any evidence of indebtedness and the Documents including, without limitation, any
22 and all costs, fees and expenses incurred by or on behalf of the County in connection with the
23 authorization, issuance, sale and delivery of any indebtedness, and all costs incurred in

1 connection with the development of the Documents, including the fees of counsel to the County,
2 and compensation to any persons (other than full-time employees of the County) or entities
3 performing services for or on behalf of the County in connection therewith and in connection
4 with all other transactions contemplated by this Bill regardless of whether the proposed financing
5 is consummated;

6 (e) the name or designation of the indebtedness, provided that unless
7 otherwise designated, the indebtedness shall be known as Harford County, Maryland Water and
8 Sewer Bonds, Series 2020;

9 (f) such other matters in connection with the consummation of the financing
10 transactions contemplated by this Bill as may be deemed appropriate by the County Executive,
11 including (without limitation) the appointment of agents (including, but not limited to, trustees,
12 paying agents, indexing agents and/or registrars) in connection with the financing, the execution,
13 acknowledgment, sealing and delivery of such other and further agreements, documents and
14 instruments, and the authorization of the officials of the County to take any and all actions, as are
15 or may be necessary or appropriate to consummate the transactions contemplated by this Bill in
16 accordance with the terms hereof and of any administrative resolution adopted by the County
17 Council under, pursuant to or in accordance with this Bill.

18 (g) Without limiting the foregoing, the County Council may provide by
19 administrative resolution that any or all of the determinations described in this Section 3 may be
20 made by executive order of the County Executive with the same force and effect as if made by
21 the County Council in accordance with an administrative resolution. In addition, any other
22 matters described in this Bill that may be determined by either administrative resolution of the
23 County Council or executive order of the County Executive shall be determined by

1 administrative resolution of the County Council unless the County Council expressly provides
2 otherwise by an administrative resolution that such matters may be determined by executive
3 order of the County Executive.

4 **SECTION 4. AND BE IT FURTHER ENACTED BY THE COUNTY COUNCIL**
5 **OF HARFORD COUNTY, MARYLAND** that authority is hereby conferred on the County
6 Executive, the Director of Administration, the Treasurer of the County (the “Treasurer”), the
7 County Attorney of the County and the Council Administrator of the County Council, or any of
8 them, and they are each hereby directed to take the following actions on behalf of the County:

9 (a) to execute, acknowledge, seal and deliver the Documents substantially in
10 the forms determined by administrative resolution of the County Council or executive order of
11 the County Executive; and

12 (b) to execute, acknowledge, seal and deliver such other and further
13 certificates, certifications, agreements, documents and instruments and take such other acts as
14 they or any one or more of them may deem necessary or appropriate to consummate the
15 transactions contemplated by this Bill in accordance with the provisions hereof and of any
16 resolution adopted by the County Council or executive order issued by the County Executive
17 under, pursuant to or in accordance with this Bill.

18 **SECTION 5. AND BE IT FURTHER ENACTED BY THE COUNTY COUNCIL**
19 **OF HARFORD COUNTY, MARYLAND** that the Treasurer is hereby authorized and
20 empowered to prepare and distribute copies of the Documents to any person who may, in the
21 Treasurer’s judgment, be interested in participating in the financing of the Projects or who may
22 request the same or information with respect thereto; provided, however, that any preliminary

1 offering documents and related material shall be clearly marked to indicate that they are subject
2 to completion and amendment.

3 **SECTION 6. AND BE IT FURTHER ENACTED BY THE COUNTY COUNCIL**
4 **OF HARFORD COUNTY, MARYLAND** that the County intends to provide funds for
5 payment of principal of, premium (if any) and interest on the bonds, or other indebtedness
6 authorized herein, after payment of operating expenses, from certain funds related to operation of
7 the water and sewer systems of the County. These funds include area connection charges, special
8 assessments, user surcharges, system development fees, certain depreciation reserves relating to
9 depreciation of the water and sewer systems and earnings on the above-described funds.

10 To the extent any of the above-described funds are specifically designated for payment of
11 debt service on bonds or other indebtedness authorized herein, issued to acquire or construct
12 improvements to the water and sewer systems of the County, by the legislation establishing the
13 tax, assessment, surcharge or other source of revenue so designated, and so long as such tax,
14 assessment, surcharge or other revenue source remains so designated and levied by the County,
15 the County hereby covenants to apply all such designated revenues to payments of debt service
16 on bonds or other indebtedness issued to acquire or construct improvements to the water and
17 sewer systems of the County, including the bonds or other indebtedness authorized herein.

18 In the event that the funds described in this Section 6 (whether or not designated for water
19 and sewer system debt service) fail to provide sufficient funds at any time while any of the bonds
20 or other indebtedness authorized herein are outstanding for the purpose of paying principal of,
21 premium (if any) and interest on the bonds or other indebtedness herein authorized, when due
22 and payable, the County hereby covenants and agrees, with each of the holders, from time to
23 time, of any of the bonds or other indebtedness, that it shall promptly cause to be levied against

1 all assessable property within the County annually, so long as any of the bonds or other
2 indebtedness is outstanding and not paid, an *ad valorem* tax sufficient in rate and amount to
3 provide for payment of such principal of, premium (if any) and interest on the bonds or other
4 indebtedness when due. Such tax shall be levied in accordance with the Charter. The County, by
5 the passage of this Bill, hereby covenants and agrees properly and promptly to perform all of the
6 respective acts and duties defined in the Charter for the levy and collection of the aforesaid *ad*
7 *valorem* tax upon all the assessable property within the corporate limits of the County, as the levy
8 and collection of such a tax becomes necessary in order to provide for the payment of principal
9 of, premium (if any) and interest on the bonds or other indebtedness.

10 **SECTION 7. AND BE IT FURTHER ENACTED BY THE COUNTY COUNCIL**
11 **OF HARFORD COUNTY, MARYLAND** that if the County Council determines by
12 administrative resolution or the County Executive determines by executive order, as the case may
13 be, that it is in the best interests of the County to sell any bonds or other indebtedness by private
14 (negotiated) sale, the County Council hereby authorizes (a) the appointment of an underwriter
15 (the “Underwriter”) in connection with the sale thereof, and (b) the payment by the County to the
16 Underwriter out of the proceeds of the sale thereof or otherwise for services rendered in
17 connection therewith, such compensation to be determined by administrative resolution of the
18 County Council or executive order of the County Executive.

19 **SECTION 8. AND BE IT FURTHER ENACTED BY THE COUNTY COUNCIL**
20 **OF HARFORD COUNTY, MARYLAND** that the County Executive is hereby authorized and
21 empowered for and on behalf of the County (a) to cause the preparation, printing, execution and
22 delivery of the Documents, each substantially in the form provided by administrative resolution
23 of the County Council or executive order of the County Executive, with such modifications,

1 supplements or amendments thereto as may be recommended by counsel; and (b) to do all such
2 things as may be necessary or desirable in the opinion of the County Executive in connection
3 therewith.

4 **SECTION 9. AND BE IT FURTHER ENACTED BY THE COUNTY COUNCIL**
5 **OF HARFORD COUNTY, MARYLAND** that nothing herein contained shall authorize the
6 expenditure of County funds until such time as such expenditure shall have been appropriated by
7 the County Council and this Bill shall not be construed as authorizing or approving any project
8 not otherwise authorized or approved by all appropriate legal authorization.

9 **SECTION 10. AND BE IT FURTHER ENACTED BY THE COUNTY COUNCIL**
10 **OF HARFORD COUNTY, MARYLAND** that unless changed by administrative resolution of
11 the County Council or executive order of the County Executive, if the indebtedness herein
12 authorized is evidenced by bonds: (a) the bonds shall be issued pursuant to the authority of this
13 Bill and shall be dated the date of issuance thereof; (b) the bonds shall be issued in the
14 denominations of Five Thousand Dollars (\$5,000) or any integral multiple thereof (and the
15 amount of bonds to be issued by the County may be adjusted by administrative resolution of the
16 County Council or executive order of the County Executive so that each bond will be in a \$5,000
17 denomination, but in no event may the aggregate indebtedness incurred pursuant to this Bill
18 exceed Five Hundred Thirty Thousand Dollars (\$530,000.00), and shall be numbered from one
19 (1) consecutively upward in the order of their maturities. The bonds shall mature over a period
20 not to exceed twenty (20) years from their date in not more than twenty (20) installments
21 beginning in the year 2020 and ending in the year 2039, unless changed by administrative
22 resolution of the County Council or executive order of the County Executive. Unless changed by
23 administrative resolution of the County Council or executive order of the County Executive, the

1 bonds shall mature on October 1 in each of said years as follows: Twenty-Five Thousand Dollars
2 (\$25,000.00) in each of the years 2020 through 2038, inclusive, and Fifty-Five Thousand Dollars
3 (\$55,000.00) in 2039. The term and maturity schedule of the bonds may be changed, increased or
4 decreased by administrative resolution of the County Council or executive order of the County
5 Executive, but the aggregate principal amount of indebtedness to be incurred shall not exceed
6 Five Hundred Thirty Thousand Dollars (\$530,000.00).

7 **SECTION 11. BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF**
8 **HARFORD COUNTY, MARYLAND** that if the indebtedness herein authorized is evidenced
9 by bonds, the bonds shall bear interest at the rate or rates named by the successful bidder for the
10 bonds in accordance with the Notice of Sale hereinafter set forth, as may hereafter be amended,
11 upon written recommendation of the County Executive, by administrative resolution of the
12 County Council, and said interest shall be payable semiannually on the first day of October and
13 April (or on such other dates as may be approved by administrative resolution of the County
14 Council or executive order of the County Executive) in each of the years that the bonds are
15 outstanding. Interest on the bonds will be payable by check or draft of the paying agent for the
16 bonds (the "Paying Agent") mailed to the registered owners thereof. The bonds, when issued,
17 shall be executed in the name of the County, by the facsimile (or original) signature of the
18 County Executive, and a facsimile (or original) of the corporate seal of the County shall be
19 imprinted or otherwise reproduced on each of the bonds attested by the facsimile (or original)
20 signature of the Director of Administration and the manual signature of an authorized officer of
21 the bond registrar for the bonds (the "Bond Registrar"). Such facsimiles and seal shall be
22 engraved, printed or lithographed or otherwise reproduced on each of the bonds in accordance
23 with, and pursuant to the authority of Sections 2-301 through 2-306 inclusive of the State

1 Finance and Procurement Article of the Annotated Code of Maryland (2015 Replacement
2 Volume and 2018 Supplement). If the indebtedness is evidenced by bonds, the bonds shall be
3 subject to registration as to principal and interest, in the name or names of the owner or owners
4 thereof on books kept for that purpose at the principal office of the Bond Registrar and the
5 principal of the bonds shall be payable upon presentation and surrender thereof at the principal
6 office of the Paying Agent or the ownership of the indebtedness may, pursuant to an
7 administrative resolution of the County Council or executive order of the County Executive, be
8 maintained by a book-entry system. The Bond Registrar and Paying Agent shall be determined
9 by administrative resolution of the County Council or executive order of the County Executive.
10 Payment of interest on the bonds shall be made by the Paying Agent on each payment date, to
11 each person appearing on the registration books of the County, maintained by the Bond Registrar,
12 as the registered owner thereof, by check or draft mailed to each such registered owner at his or
13 her address as it appears on such registration books. There shall be printed on each bond (or
14 delivered therewith) the text of the approving legal opinion of bond counsel with respect to the
15 bonds. Except as provided hereinafter or in an administrative resolution of the County Council
16 or executive order of the County Executive prior to the issuance of the bonds, if the indebtedness
17 authorized herein is evidenced by bonds, the bonds shall be in substantially the following form,
18 which form, together with all covenants and conditions therein contained, is hereby adopted by
19 the County Council as and for the form of obligation to be incurred by the County as bonds, and
20 any and all covenants and conditions therein contained, including (without limitation) the
21 promise to pay, are hereby made binding upon the County:

30 The County will undertake to provide the successful bidder with further additional information to be
31 included in the Official Statement, when in the opinion of the County or of Bond Counsel, such additional
32 information constitutes a material change to the Official Statement. The County will take such steps as are necessary
33 to arrange for amending and supplementing the Official Statement in connection with the disclosure of such
34 additional information; provided, however, that the County shall have no obligation to provide such additional
35 information after the date that is twenty-five (25) days after the “end of the underwriting period,” as such term is
36 defined in the Rule.
37

38 The County agrees, in order to assist the successful bidder in complying with Section (b)(5) of the Rule,
39 pursuant to a continuing disclosure certificate (the “Continuing Disclosure Certificate”) signed by the County
40 Executive, Treasurer and Director of Administration of the County, to provide annual financial information and
41 notices of certain events, as enumerated in the Rule, to the Electronic Municipal Market Access (“EMMA”) System
42 implemented by the Municipal Securities Rulemaking Board established pursuant to Section 15B(b)(1) of the
43 Securities Exchange Act of 1934. The undertakings of the County in the Continuing Disclosure Certificate shall be
44 set forth in the Preliminary Official Statement and Official Statement and any amendment or supplement thereto.
45

46 **Certification as to Issue Price**
47

48 The successful bidder shall assist the County in establishing the issue price of the Bonds and shall execute and
49 deliver to the County on or before the date of issue of the Bonds, an “issue price” or similar certificate setting forth
50 the reasonably expected initial offering price to the public or the sales price or prices of the Bonds together with the
51 supporting pricing wires or equivalent communications as described herein.
52

53 The County intends and expects that the provisions of Treasury Regulation Section 1.148-1(f)(3)(i) (defining

6 Counsel, on or before the date of issue of the Bonds, substantially in the form attached hereto as Exhibit A, with such
7 modifications as may be appropriate or necessary, in the reasonable judgment of the successful bidder, the County
8 and Bond Counsel. The County's Financial Advisor acting as its municipal advisor (the "Municipal Advisor") shall
9 also be required to provide to the County a certificate acceptable to Bond Counsel on or before the date of issue of
10 the Bonds, substantially in the form attached hereto as Exhibit B, with such modifications as may be appropriate or
11 necessary, in the reasonable judgment of the Municipal Advisor, the County and Bond Counsel.
12

13 In the event that a bid fails to satisfy the requirements of a Qualified Competitive Bid (an "Alternate
14 Competitive Bid"), the County shall so advise the successful bidder. The County may determine to treat (i) the first
15 price at which 10% of a maturity of the Bonds (the "10% test") is sold to the public as the issue price of that maturity
16 and/or (ii) the initial offering price to the public as of the sale date of any maturity of the Bonds as the issue price of

11 *ad valorem* tax upon all the assessable property within the corporate limits of the County, as the
12 levy and collection of such a tax becomes necessary in order to meet the debt service
13 requirements of the Harford County, Maryland Water and Sewer Bonds, Series 2019. By this
14 Bill, the County agrees to take all action it may be legally authorized and empowered to take in
15 order to enforce, in any year in which any of the bonds or other indebtedness are outstanding, the
16 guarantee of such bonds or other indebtedness by the County.

17 **SECTION 17. BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF**
18 **HARFORD COUNTY, MARYLAND** that as a part or all of the aggregate indebtedness
19 authorized by this Bill, upon written recommendation of the County Executive and adoption of
20 the Administrative Resolution (as defined in Section 17B of this Bill), the County shall borrow
21 upon its full faith and credit and unlimited taxing power of the County a loan (the “Water Quality
22 Loan”) from the Maryland Water Quality Financing Administration (the “WQFA”), and shall
23 issue and sell to the WQFA upon its full faith and credit and unlimited taxing power the bonds in

1 the form of a single, fully-registered bond in the principal amount not to exceed Five Hundred
2 Thirty Thousand Dollars (\$530,000.00) pursuant to the authority of the Charter, the Code, the
3 Local Government Article of the Annotated Code of Maryland, and Title 9 of the Environment
4 Article of the Annotated Code of Maryland (2014 Replacement Volume and 2018 Supplement)
5 (the “Water Quality Act”) for the upgrade, expansion and improvement of all or part of the
6 Projects. The sale of the bonds shall be conducted as more fully described in this Section 17 and
7 the aggregate amount of bonds otherwise authorized by this Bill shall be reduced by the amount
8 of the bonds sold pursuant to the Water Quality Act. The County hereby determines to borrow
9 money and incur indebtedness for the public purpose of financing the costs of the acquisition and
10 development of the Projects which shall include: (i) actual and estimated costs of the issuance of
11 the bonds, (ii) engineering expenses, (iii) inspection expenses, (iv) fiscal expenses, (v) legal
12 expenses; and (vi) interest estimated to accrue during the construction and for 24 months on
13 money borrowed or expected to be borrowed. The development costs shall be more fully
14 described in the Administrative Resolution. It is the intent of the County Council that the costs
15 of the Projects be financed with the proceeds from the sale of the bonds and that the County also
16 be reimbursed out of the proceeds of the bonds for all costs of acquisition incurred by the
17 County; provided, however, that such expenses have been incurred by the County not more than
18 one (1) year prior to the issuance of the bonds:

19 A. Each of the Projects shall constitute a “wastewater facility” within the
20 meaning of Section 9-1601 of the Water Quality Act.

21 B. Such borrowing and indebtedness of the County shall be made and incurred
22 pursuant to Section 9-1606 and Section 9-1614(b) of the Water Quality Act and in accordance
23 with the provisions of a loan agreement between the County, as borrower, and the WQFA (the

1 “Loan Agreement”). The Loan Agreement shall be substantially in such form as is approved by a
2 resolution supplemental to this Bill and passed subsequent to the enactment of this Bill (the
3 “Administrative Resolution”) which Administrative Resolution shall set forth the details of the
4 bonds and the terms of the loan, in such manner as shall not be inconsistent with the provisions
5 and requirements of this Bill. The Loan Agreement (the form of which shall be attached to the
6 Administrative Resolution and approved therein) shall contain in its final form such insertions,
7 omissions, variations, or changes (collectively “changes”) as may be deemed necessary or
8 appropriate and which shall be acceptable to the County Executive, and the County Executive is
9 hereby authorized, and shall be authorized by the Administrative Resolution, to make changes in
10 the Loan Agreement as the County Executive may deem appropriate.

11 C. To evidence the payment of obligations of the County under the Loan
12 Agreement, the County shall issue and sell, upon its full faith and credit and unlimited taxing
13 power, the bonds, as general obligation installment bonds in the maximum amount not to exceed
14 Five Hundred Thirty Thousand Dollars (\$530,000.00) which shall be in the form of one bond
15 certificate numbered R-1 and shall be designated “Harford County, Maryland Water Quality
16 Bond, Series 2020.”

17 The proceeds from the sale of the bonds shall be generally used for the purposes
18 set forth in this Section 17 as more fully described in the project description as set forth and
19 approved by the Administrative Resolution. The bonds shall be (i) dated as of the date of
20 delivery to the WQFA, (ii) registered in the name of the WQFA or its designee and (iii) payable
21 in such principal installments and shall bear interest at such rate as shall appear in the executed
22 bond certificate. The maturity of the bonds and the date of final maturity shall appear in the
23 executed bond certificate. In no event shall the final date of maturity of the bonds exceed thirty

1 (30) years from the date of issuance thereof. The interest rate borne by the bonds shall be
2 determined by the WQFA and approved in the Administrative Resolution.

3 The principal installments payable on the bonds and the rate of interest to be
4 borne thereby (or the manner of determining the principal payments and rate of interest) shall be
5 established by the Administrative Resolution. Such determination of the principal and interest on
6 the bonds shall be in accordance with the terms and conditions of the Loan Agreement. The rate
7 of interest approved by the Administrative Resolution shall in no event exceed the maximum rate
8 permitted by law and such interest rate shall appear in the executed bond certificate.

9 The form of bond, together with the statement of principal installments (annual or
10 semiannual as shall be finally approved by the County Executive pursuant to this Section 17) and
11 such installments of interest as therein set forth, and all of the covenants and conditions as shall
12 be contained therein and in the Loan Agreement shall be adopted by the County Council pursuant
13 to the Administrative Resolution and any and all covenants and conditions therein contained
14 shall be made binding upon the County, including (without limitation) the promise to pay.
15 Execution of the bond by the County Executive shall constitute conclusive evidence of such
16 approval.

17 D. The County will also execute and deliver in connection with the issuance of
18 the bonds, additional documents (the “Water Quality Documents”) including, but not limited to,
19 the Loan Agreement, and such other documents, agreements, instruments and certificates as the
20 County Executive, upon advice of legal counsel, shall deem necessary or desirable for the
21 financing of the acquisition of the Projects. Because this Bill is being adopted before all of the
22 details of the sale of the bonds and the issuance and sale of revenue bonds by the WQFA the
23 proceeds of which shall be used to make the Water Quality Loan to the County have been

1 finalized, the County Executive, pursuant to the powers reserved unto him under this Section 17
2 and as set forth in the Administrative Resolution, is hereby authorized to make changes to the
3 forms of the bonds and the Water Quality Documents, including insertions therein or additions
4 thereto or deletions therefrom, as the County Executive may deem necessary to conform the
5 terms of the bonds and the Water Quality Documents to the terms of the financing to be provided
6 to the County by the WQFA; provided, however, that such changes, additions or deletions are not
7 in substance inconsistent with or contrary to the requirements set forth in this Bill or in the
8 Administrative Resolution.

9 E. The Loan Agreement and the bonds shall be executed on behalf of and in the
10 name of the County by the County Executive, such execution to be made by the manual or
11 facsimile signature of the County Executive as permitted by law. The corporate seal of the
12 County shall be affixed to or otherwise reproduced on the Loan Agreement and the bonds, and
13 shall be attested by the manual or facsimile signature of the Director of Administration as
14 permitted by law. If any officer whose signature shall appear on the bonds or the Water Quality
15 Documents shall cease to be such officer before the delivery of the bonds or the Water Quality
16 Documents, such signature shall nevertheless be valid and sufficient for all purposes, the same as
17 if such officer had remained in office until such delivery. The County Executive is hereby
18 authorized, empowered and directed to complete the forms of the bonds and the Water Quality
19 Documents as such forms may be approved by the County Council through the Administrative
20 Resolution and the County Executive shall make corrections or changes thereto in any manner
21 which the County Executive, in the County Executive's discretion, shall deem necessary to
22 complete the issuance and sale of the bonds and the execution and delivery of the Water Quality
23 Documents, all as may promote the objectives of the County as set forth in this Bill. The Water

1 Quality Documents and the bonds, as executed by the County Executive and attested and sealed
2 as described above, shall be valid and legally binding obligations of the County in accordance
3 with their terms.

4 F. Notwithstanding any section of the Charter, the Code, Section 19-205 of the
5 Local Government Article of the Annotated Code of Maryland (2013 Replacement Volume and
6 2018 Supplement) or any other provision of public general or public local law, charter or
7 ordinance, and as authorized by Section 9-1606 of the Water Quality Act, the bonds may be sold
8 at private sale to the WQFA, without public bidding or regard to any limitations on the
9 denomination thereof and at any interest or cost or at any price that the County considers
10 necessary or desirable, and such private sale is determined to be in the best interests of the
11 County. The details of the sale of the bonds shall be determined in accordance with the
12 Administrative Resolution. The bonds shall be sold for cash at not less than par in accordance
13 with the terms and provisions of this Bill and the Administrative Resolution. The County
14 Executive, in the County Executive's discretion, is expressly authorized and empowered to take
15 any and all action necessary to complete and close the award, sale and delivery of the bonds to
16 the WQFA, including (without limitation) making changes to the form of bond as the County
17 Executive may deem to be necessary or appropriate to comply with WQFA practices and policies
18 applicable from time to time; provided, however, that such actions taken by the County
19 Executive shall not be in substance inconsistent with or contrary to the provisions of this Bill or
20 the Administrative Resolution.

21 G. The proceeds of sale of the bonds to the WQFA shall be held, invested and
22 administered by the WQFA pursuant to the Loan Agreement and shall be used, when and as
23 required, to be applied from time to time as and when received by the County to finance costs of

1 the Projects in compliance with the provisions of the Loan Agreement, the Charter, the Code and
2 the Water Quality Act. Any balance of the proceeds of the Water Quality Loan remaining
3 subsequent to payment in full of all the costs of the Projects may be applied to reduce the
4 principal of the Water Quality Loan in accordance with the terms of the Loan Agreement.

5 H. For the purpose of paying the principal of, premium (if any) and interest on the
6 bond when due, the County has established or shall establish a dedicated source of revenues as
7 shall be described in the Loan Agreement. In the event such revenues are insufficient to meet the
8 debt service requirements in any fiscal year in which the bonds are outstanding, the County shall
9 levy in such fiscal year upon all real and tangible personal property within its jurisdictional limits
10 subject to assessment for unlimited County taxation *ad valorem* taxes in rate and amount
11 sufficient to provide for the prompt payment of such principal, premium (if any) and interest on
12 the bonds in such fiscal year, and, if the proceeds from the collection of taxes so levied in any
13 such fiscal year are inadequate for such payment, additional taxes shall be levied in the
14 succeeding fiscal year to make up such deficiency. The full faith and credit and unlimited taxing
15 power of the County are hereby irrevocably pledged to the payment of the principal of, premium
16 (if any) and interest on the bonds as and when they become due and payable and to the levy and
17 collection of the taxes hereinabove described as and when such taxes may become necessary in
18 order to provide sufficient funds to meet the debt service requirements of the bonds. The County
19 hereby covenants and agrees with the registered owner of the bonds to levy and collect the taxes
20 hereinabove described and to take any action that may be appropriate from time to time during
21 the period that the bonds remain outstanding and unpaid to provide the funds necessary to pay
22 promptly the principal and interest due thereon.

1 I. The bonds are being issued in connection with the WQFA’s Maryland Water
2 Quality Revolving Loan Fund Program and will evidence the County’s obligation to repay the
3 Water Quality Loan advanced from the proceeds of the sale of revenue bonds issued by the
4 WQFA. The Loan Agreement limits the ability of the County to prepay the bond in accordance
5 with restrictions upon the ability of the WQFA to redeem its revenue bonds. Accordingly, the
6 County may prepay the bonds only in accordance with the provisions of the Loan Agreement and
7 the terms governing prepayment as set forth in the bonds.

8 J. The County Executive shall be the certifying official for the County responsible
9 for the execution and delivery on the date of the issuance of the bonds of a tax and arbitrage
10 certificate of the County (the “Tax Certificate”) that complies with the requirements of Section
11 148 of the Internal Revenue Code of 1986, as amended, and the applicable regulations thereunder
12 (“Section 148”). The County Executive is hereby authorized and directed to execute and deliver
13 the tax and arbitrage certificate to counsel rendering an opinion on the excludability from gross
14 income of interest on the bonds for purposes of federal income taxation on the date of the
15 issuance thereof. The Tax Certificate shall set out the reasonable expectations of the County as
16 to relevant facts, estimates and circumstances relating to the use of the proceeds of the bonds or
17 of any moneys, securities or other obligations to the credit of any account of the County which
18 may be deemed to be bond proceeds under Section 148. The County covenants with the
19 registered owner of the bonds that the facts, estimates and circumstances set forth in the Tax
20 Certificate will be based on the County’s reasonable expectations on the date of the issuance of
21 the bonds and will be, to the best of the certifying official’s knowledge, true, correct and
22 complete as of that date.

1 K. The County covenants and agrees with the registered owner of the bonds that
2 it will not make, or (to the extent that it exercises control or direction) permit to be made, any use
3 of the bond proceeds that would cause any bond to be an “arbitrage bond” within the meaning of
4 Section 148. The County further covenants that it will comply with Section 148 to the extent
5 applicable to the bonds on the date of issuance thereof and which may subsequently lawfully be
6 made applicable to the bonds. The County further covenants that it shall make such use of the
7 proceeds of the bonds, to the extent possible regulate the investment of the proceeds thereof, and
8 take such other and further actions as may be required to maintain the excludability from gross
9 income, for federal income tax purposes, of interest on the bonds. All officers, employees and
10 agents of the County are hereby authorized and directed to take such actions, and to provide such
11 certificates of facts and estimates regarding the amount and use of the proceeds of the bonds, as
12 may be necessary or appropriate from time to time to comply with, or to evidence the County’s
13 compliance with, the covenants set forth in this Section 17.

14 L. The principal amount of the bonds to be sold to the WQFA pursuant to the
15 Water Quality Act shall be determined in a resolution adopted by the County Council upon
16 written recommendation of the County Executive and shall constitute a portion or all of the Five
17 Hundred Thirty Thousand Dollars (\$530,000.00) principal amount of indebtedness authorized to
18 be incurred pursuant to this Bill. In no event may the aggregate indebtedness incurred by the
19 County to finance the Projects pursuant to this Bill exceed Five Hundred Thirty Thousand Dollars
20 (\$530,000.00).

21 **SECTION 18. BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF**
22 **HARFORD COUNTY, MARYLAND** that the County is hereby authorized and empowered
23 from time to time to issue its bond anticipation notes (or other evidence of indebtedness) on the

1 full faith and credit and unlimited taxing power of the County in an amount not exceeding Five
2 Hundred Thirty Thousand Dollars (\$530,000.00), the net proceeds of such sale to be used to
3 finance part or all of the cost of the Projects; the sale of such notes to be upon such terms as may
4 be directed by resolution of the County Council.

5 The Treasurer prior to the issuance of any bond anticipation notes or other evidence of
6 indebtedness of the County shall present the terms of such notes to the County Council for
7 approval by administrative resolution of the County Council prior to the issuance thereof.

8 The bond anticipation notes will bear interest at the rate or rates so negotiated by the
9 Treasurer and approved by administrative resolution of the County Council and the bond
10 anticipation notes when issued shall be issued in the name of the County by the signature of the
11 County Executive, the corporate seal of the County shall be imprinted or otherwise reproduced
12 on the bond anticipation notes and attested by the Director of Administration and shall be used
13 only for those purposes approved by administrative resolution of the County Council adopted
14 subsequent to the adoption of this Bill.

15 The bond anticipation notes shall not be issued in an amount greater than the amount of
16 bonds or other indebtedness authorized in anticipation of the sale of which the bond anticipation
17 notes are issued and sold.

18 The principal of and interest on the bond anticipation notes shall be payable out of the
19 first proceeds of sale of the bonds, or from the tax or other revenue which the County shall
20 previously determine to apply to the payment of the bonds and interest thereon.

21 Twelve (12) months interest on the bond anticipation notes or any renewal thereof may be
22 paid from the proceeds of sale of the bonds accounting from the initial date of issue thereof.

1 By administrative resolution of the County Council, the County may provide for the
2 renewal of the bond anticipation notes at maturity with or without resale.

3 Immediately after the sale of the bond anticipation notes and approval by resolution of the
4 County Council, the proceeds of sale of such bond anticipation notes, after payment of expenses
5 of issuing the same, shall be paid to the County's Department of the Treasury. The proceeds of
6 sale of the bond anticipation notes shall be expended only to finance the Projects.

7 **SECTION 19. BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF**
8 **HARFORD COUNTY, MARYLAND** that pursuant to Treasury Regulations 1.150-2,
9 governing the use of bond proceeds for the purpose of reimbursing expenditures paid prior to the
10 issuance of bonds, and as permitted by Treasury Regulations 1.150-2(e)(1), the Treasurer is
11 hereby duly designated to make declarations of Official Intent on behalf of the County. The
12 County expects that all or a part of the capital expenditures for the Projects will be paid prior to
13 the issuance of the bonds authorized herein, and that the proceeds of the bonds will be used to
14 reimburse the County for capital expenditures paid prior to the issuance of the bonds. The
15 County reasonably expects to reimburse a portion of the capital expenditures for the Projects
16 with proceeds of the bonds, in the maximum principal amount of Five Hundred Thirty Thousand
17 Dollars (\$530,000.00), and this Bill shall be available for public inspection at the offices of the
18 County during regular business hours and in accordance with the laws of the State of Maryland
19 and the County, regarding access to public records. The maximum principal amount of debt
20 which is expected to be issued for the Projects is \$530,000.00.

21 **SECTION 20. BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF**
22 **HARFORD COUNTY, MARYLAND** that the County covenants and agrees with the registered
23 owners, from time to time, of the bonds as follows:

1 (a) The County covenants that it will not make any use of the proceeds of any of
2 the bonds or any moneys, securities or other obligations on deposit to the credit of the County or
3 otherwise which may be deemed by the Internal Revenue Service to be proceeds of any of the
4 bonds pursuant to the Internal Revenue Code of 1986, as amended, and Income Tax Regulations
5 thereunder (collectively, the “Tax Code”), which would cause any of the bonds to be “arbitrage
6 bonds” or “private activity bonds” within the meaning of the Tax Code.

7 (b) The County further covenants that it will comply with those provisions of the
8 Tax Code that are applicable to the bonds on the date of issuance thereof and which may
9 subsequently lawfully be made applicable thereto. To the extent that provisions of the Tax Code
10 apply to only a portion of the bonds, proceeds of the bonds or other moneys, securities or other
11 obligations deemed to be proceeds, it is intended that the covenants of the County contained in
12 this Section 20 be construed so as to require the County to comply with the provisions of the Tax
13 Code only to the extent of such applicability.

14 (c) The County further covenants that it will not (i) take any action, (ii) fail to
15 take any action, or (iii) make any use of the proceeds of any of the bonds which would cause the
16 interest on any of the bonds to be or become subject to federal income taxes in the hands of the
17 registered owners of any of the bonds.

18 (d) The County further covenants, in order to assist bidders in complying with
19 SEC Rule 15c2-12(b)(5), pursuant to a continuing disclosure agreement (the “Continuing
20 Disclosure Agreement”) signed by the County Executive, Treasurer and Director of
21 Administration, to provide annual reports and notices of certain events. The undertaking of the
22 County in the Continuing Disclosure Agreement shall be described in any Preliminary Official
23 Statement and Official Statement and any amendment or supplement thereto.

1 **SECTION 21. BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF**
2 **HARFORD COUNTY, MARYLAND** that upon recommendation of the County Executive, the
3 County Council may adopt a resolution pursuant to Section 19-101 of the Local Government
4 Article of the Annotated Code of Maryland (2013 Replacement Volume and 2018 Supplement)
5 authorizing the loan authorized to be incurred and the bonds authorized to be sold by this Bill, to
6 be consolidated for sale and issued, sold and delivered as a single issue of bonds with other
7 bonds authorized to be sold to finance capital projects described in the Annual Budget and
8 Appropriation Ordinances, as amended, for the current fiscal year and/or prior or subsequent
9 fiscal years.

10 **SECTION 22. BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF**
11 **HARFORD COUNTY, MARYLAND** that the provisions of this Bill are severable, and if any
12 provision, sentence, clause, section or part hereof is held illegal, invalid or unconstitutional or
13 inapplicable to any person or circumstances, such illegality, invalidity or unconstitutionality, or
14 inapplicability shall not affect or impair any of the remaining provisions, sentences, clauses,
15 sections or parts of this Bill or their application to other persons or circumstances. It is hereby
16 declared to be the legislative intent that this Bill would have been passed if such illegal, invalid
17 or unconstitutional provision, sentence, clause, section or part had not been included herein, as if
18 the person or circumstances to which this Bill or any part hereof are inapplicable had been
19 specifically exempted therefrom.

20 **SECTION 23. AND BE IT FURTHER ENACTED BY THE COUNTY COUNCIL**
21 **OF HARFORD COUNTY, MARYLAND** that this Bill shall take effect sixty (60) calendar
22 days from the date it becomes law.

40 INTRODUCTION
