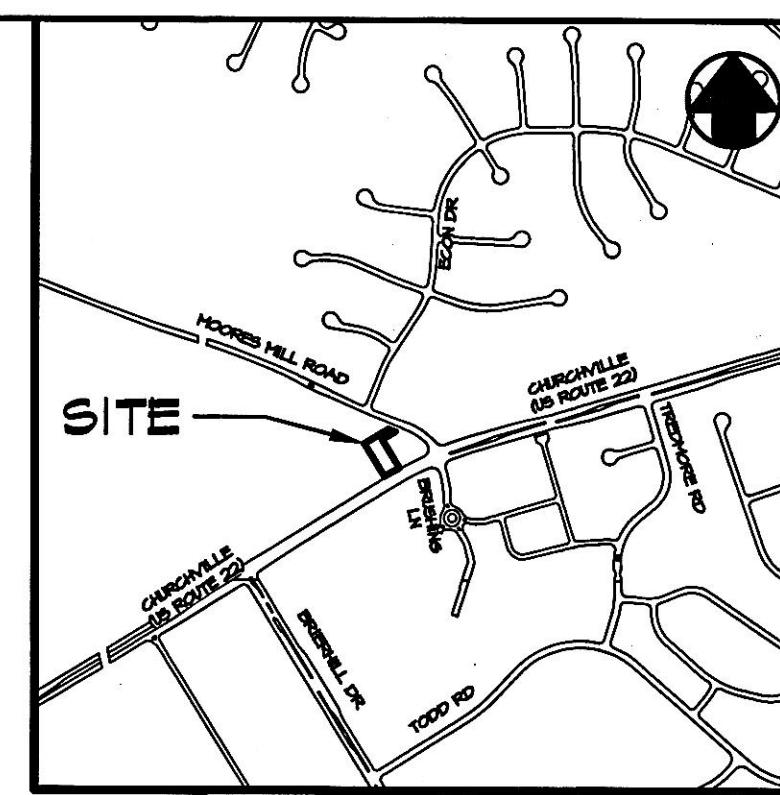
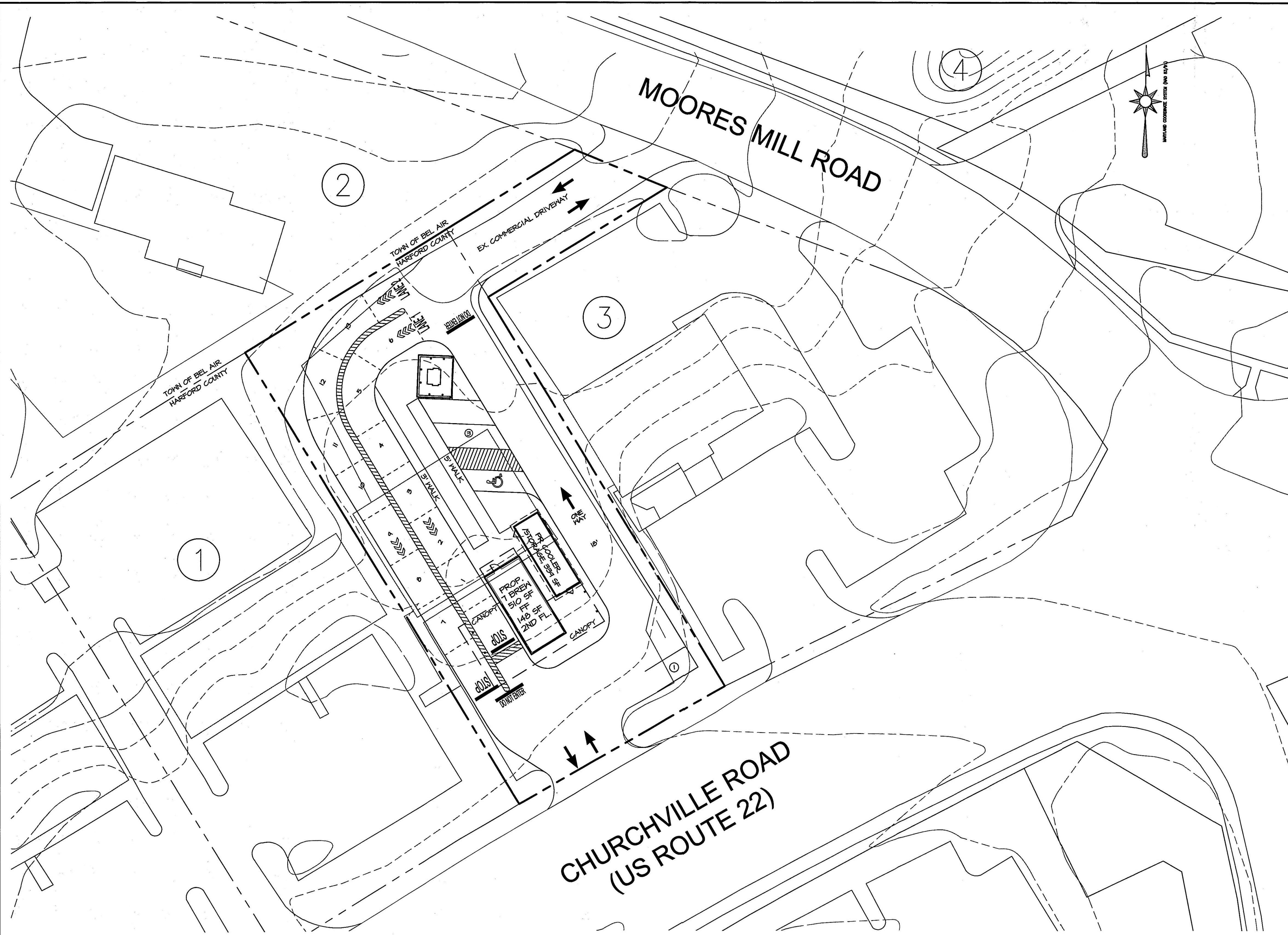

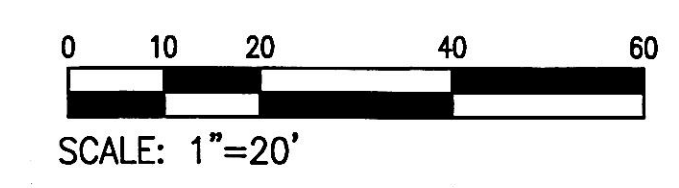
LOCATION MAP
