Minutes:

- Meeting was called to order by Laura Stewart.
- March minutes were approved.
- There was no public safety report due to Harford County Sheriff unable to attend meeting.
- Larry Richardson provided a legislative update. Revenue projections from the State of Maryland to Harford County have decreased approximately \$13M. Goal of County Executive is conservative fiscal management rather than raising taxes. There will be 2 public input sessions for budget work sessions and County Council Chambers on May 8 & May 13.
- Terry Hanley provided an update from Parks & Rec. The Ma & Pa trail extension project will re-start in Fall and will run for 18 months to complete the connection of the trail. Tucker field will receive new bleachers, partnering with BARC. CMW will receive a new turf field this summer. Prospect Mill Park has had baseball field resodded. Friends Park will be receiving a new playground. Shucks Road park will have bathrooms and concessions installed.







RIDER MUST BE:

- At least 8 years old by the start of camp and have a disability
- Able to walk without an assistive device and sidestep to both sides
- Able to attend all sessions during the 5-day camp
- Under 220 lbs. and have a minimum inseam measurement of 20" (*measured from floor with sneakers on*)
- Willing and able to wear a properly fitted bike helmet
