The Maryland Thoroughbred Racetrack Operating Authority has been tasked by the Senate Budget and Taxation Committee, the House Appropriations Committee and the House Ways and Means Committee to study the feasibility of establishing at least two alternative Thoroughbred training facilities in the State.

The proposed Mitchell Farm Training Center represents a significant opportunity for our State's Thoroughbred racing industry. The comprehensive facilities described in the Maryland

Thoroughbred Racetrack Operating Authority's Racing & Training Center Development Report present a compelling case for the selection of this location.

The Mitchell Farm Training Center's features, including two training tracks, ample training stalls, an equine wellness center, and dormitories, signify a commitment to providing state-of-the-art amenities for both horses and trainers. Furthermore, the report's assessment of the site's suitability, emphasizing its flat terrain and absence of natural resource challenges, reinforces the viability of this location for the proposed training center.

Given these considerations, and the fact that the Mitchell Farm Training Center had the highest ranking of all the locations, I am asking for your support in establishing a Thoroughbred training

facility at the Mitchell Farm Training Center. I firmly believe that this facility will not only enhance Maryland's reputation as a hub for Thoroughbred racing, but also contribute positively to the local economy and community.


