1 WHEREAS, the County Council enacted Bill 92-89 effective February 9, 1993 which
2 provided for a property tax credit for properties under certain circumstances that are in close
3 proximity to a landfill; and

4 WHEREAS, Bill 92-89 provided that the County Council shall determine by law the
5 properties adversely impacted by their proximity to the landfill; and

6 WHEREAS, on February 16, 2010, the County Council enacted Bill 10-02, which
7 increased the boundaries to within 1,000 feet of a refuse disposal system; and

8 WHEREAS, 34 applications were submitted and reviewed for compliance with the
9 provisions of these Bills; and

10 WHEREAS, it was determined that these 34 properties meet the parameters of Bill Nos.
11 92-89 and 10-02.

12 NOW THEREFORE,

13 Section 1. Be It Enacted By the County Council of Harford County that the following real
14 properties receive a tax credit for the tax year that shall begin on July 1, 2021:
