AN ACT to repeal and reenact, with amendments, Subsection A of Section 256-45.4, System development fee for water and sewer, of Article V, Capital Charges, of Chapter 256, Water and Sewers, of the Harford County Code, as amended; to modify the system development annual escalation from 6% to 4.5%; and generally relating to water and sewers.

1 Section 1. Be It Enacted By The County Council of Harford County, Maryland that Subsection A
2 of Section 256-45.4, System development fee for water and sewer, of Article V, Capital Charges, of
3 Chapter 256, Water and Sewers, of the Harford County Code, as amended, be, and it is hereby, repealed
4 and reenacted, with amendments, all to read as follows:

5 **Chapter 256. Water and Sewers**

6 **Article V. Capital Charges**

7 **§ 256-45.4. System development fee for water and sewer.**

8 A. A system development fee is hereby established as an additional fee on every water and/or
9 sewer connection as follows:


10 (1) The water system development fee per EDU is [\$2,633.00] CURRENTLY \$4,194,
11 which shall be increased annually each July 1 by [6%] 4.5%.

12 (2) The sewer system development fee per EDU is [\$5,438.00] CURRENTLY \$8,669,
13 which shall be increased annually each July 1 by [6%] 4.5%.

14 Section 2. And Be It Further Enacted that this Act shall take effect 60 calendar days from the date
15 it becomes law.
