Harford County Ethics Board
February 1, 2024

County Executive and Council Members:

Section 5-807 of the General Provisions Article of the Annotated Code of Maryland requires that local ethics boards provide the local governing body with a report on the administration of the local ethics law. Pursuant thereto, this report summarizes the work of the Harford County Ethics Board (the “Board”) over the past calendar year in each of the following areas:

1. Financial Disclosure Statements;
2. Lobbying;
3. Legislative and Regulatory;
4. Complaints;
5. Advisory Opinions; and
6. Administration.

Financial Disclosure Statements

The Harford County Public Ethics Law, Harford County Code (“HCC”) §§ 23-1 through 23-10 (“County Ethics Law”) requires certain officials, employees and members of certain boards to file annual financial disclosure statements. The Board oversees review of such financial disclosure statements for compliance with the provisions of the County Ethics Law. These statements are public records available for inspection in accordance with HCC § 23-6(D).

This year, notice was sent via email on April 12, 2023 to all individuals required to file a 2022 financial disclosure statement. Those individuals were provided with the option of completing the financial disclosure statement on-line or by paper copy. The notice also indicated

the filing deadline of April 30, 2023. Executive Branch cabinet members were additionally reminded during weekly Cabinet meetings of the foregoing deadline.

The attached spreadsheet, incorporated by reference herein and made a part hereof, provides details of all such filings and any amendments thereto pursuant to HCC § 23-6.

The Harford County Department of Procurement maintains a comprehensive list of County vendors, which is provided to the County Auditor and available for public access and inspection via the County website. A list of County vendors paid in excess of Five Thousand Dollars (\$5,000.00) for the reporting period is attached hereto and made a part hereof. The Board requests that the County Auditor be tasked with comparing the County vendor list with financial disclosure statements to identify and audit any potential or actual conflicts of interest.

The incident occurring in November of 2023 involving Harford County Department of Emergency Services (“DES”) Deputy Director Joseph Woods emphasizes the exigency for the County Auditor to perform the above comparison. In this instance, the County Auditor discovered that Mr. Woods, on behalf of DES, authorized the purchase of various clothing items from a company, MDQ USA, LLC, d/b/a Maryland Quartermaster (MDQ), owned by his wife, Laura Woods. Mr. Woods admitted to authorizing these purchases, which totaled the approximate amount of Eight Thousand, One Hundred and Eleven Dollars (\$8,111.00).

It is a conflict of interest and a violation of the County Ethics Law for a County employee to engage in any transaction on behalf of the County that involves the employee in his individual capacity or a “qualified relative” of such County employee. HCC §§ 23-5C(1), 23-5C(2) & 23-5D(1)(a)[2]. An employee’s spouse is a “qualified relative” of an employee. HCC § 23-5A. When Mr. Woods approved the purchase of goods from MDQ, he entered into a transaction on behalf of

the County that conferred a monetary benefit on his wife. Such action directly violated the County Ethics Law.

Thorough review of financial disclosure statements and subsequent comparison with the County vendor list shall serve to identify any potential or actual conflicts of interest such as the above, so that any issues relating thereto are resolved expeditiously.

Lobbying

The Board is responsible for maintaining all lobbying registrations and reports filed under the County Ethics Law. An individual must register as a lobbyist if the individual: (1) personally appears before a County official or employee intending to influence the individual in performance of their official duties; and (2) in connection with the intent to influence, expends or expects to expend in the calendar year in excess of One Hundred Dollars (\$100.00) on food, entertainment or other gifts for officials or employees of the County.

A registered lobbyist must file an activity report within thirty (30) days after the end of any calendar year disclosing: (1) the value, date and nature of any food, entertainment or other gift provided to a County official or employee; and (2) the identity of any official or employee who received a gift or series of gifts exceeding One Hundred Dollars (\$100.00).

The Board provides, via the Harford County Law Department website, forms for lobbyist registration and reporting as well as a list of registered lobbyists and filed reports. A copy of the list of registered lobbyists is attached hereto and made a part hereof.

Legislative and Regulatory

The Board is responsible for determining whether legislative changes are necessary to the County Ethics Law to ensure compliance with the State Ethics Law. The General Assembly modified several provisions in the State Ethics Law during the 2021 legislative session. The Board

compared these updated provisions with the current County Ethics Law. Upon review, the Board determined that updates to the Code are necessary for the County Ethics Law to conform with the State Ethics Law revisions. Additionally, the Board recommends revision of certain provisions throughout the County Ethics Law to correct misnomers and resolve issues of consistency with the State Ethics Law. The Board is preparing proposed legislation which incorporates the foregoing revisions and recommendations for the County Executive and County Council's consideration during the 2024 legislative term.

Complaints

Written complaints may be filed by any individual within three (3) years after the date of an alleged violation of the County Ethics Law. The Board publishes written decisions in response to each written complaint, which are available for public access and inspection through the Board's website. The Board issued two (2) written decisions in connection with four (4) formal written complaints filed during this reporting period.

Written complaints 23-01 and 23-04 both involve allegations that Councilwoman Jessica Boyle-Tsottles violated HCC §§ 23-5C(2)(a) & 23-5C(2)(b) in connection with her role as an "official" as defined in HCC § 23-2.1 and her ownership and financial interests in two (2) private business entities; one (1) such entity allegedly employing her husband.

Upon review and consideration of the Councilwoman's financial disclosure statement, relevant County Council voting records and minutes, public records, and discussions with the County Procurement Department, the Board concluded that the Councilwoman did not violate HCC § 23-5C(2)(a) nor HCC § 23-5C(2)(b).

Notwithstanding the above, the Board noted the Councilwoman failed to timely file her financial disclosure statement pursuant to HCC § 23-6 despite three (3) separate notifications to

comply with said provision. The Board therefore found the Councilwoman in violation of HCC § 23-6 and recommended disciplinary action in accordance with HCC § 23-9(A)(1).

Written complaints 23-02 and 23-03 both involve allegations that Councilman Aaron Penman violated Section 207 of the Harford County Charter due to his concurrent, conflicting dual roles as an elected official and as a state employee of the Harford County Sheriff's Office.

The Board concluded that both written complaints present issues of legal interpretation and therefore beyond the scope of the Board's authority.

Advisory Opinions

An "official" or "employee," as defined in HCC § 23-2.1, may request the Board to issue an advisory opinion on the application of the County Ethics Law to the official or employee. Advisory opinions are public documents and are available for public access and inspection on the Board of Ethics website. Two (2) advisory opinions were requested during this reporting period and the Board issued one (1) opinion as a result thereof.

In Advisory Opinion 23-001, Sarah Coleman, an official pursuant to HCC § 23-2.1, requested for the Board to address whether she, as a member of the Environmental Advisory Board and a member of the Parks and Recreation Advisory Board, may solicit County contracts doing landscaping, stormwater management and/or site naturalization work through businesses in which she has an ownership and/or financial interest.

The Board determined that HCC § 23-5 precluded Ms. Coleman from serving on the Environmental Advisory Board and the Parks and Recreation Advisory Board, because such service affords her an opportunity to: 1) gain invaluable knowledge and insight into future County project plans and requirements; and 2) develop valuable relationships with the County personnel who influence the award of such County contracts. As such, the Board concluded that Ms.

Coleman was disqualified from serving on the foregoing boards and given the ineluctable appearance of impropriety, did not recommend an exemption be made pursuant to HCC § 23-5(H)(6) nor HCC § 23-8. The Board commended Ms. Coleman for recognizing the foregoing potential conflict of interest and subsequently requesting that the Board provide clarification through the issuance of an advisory opinion.

The Board received one (1) additional request for an advisory opinion submitted by a Harford County resident on October 25, 2023. As the resident was neither an official nor employee pursuant to HCC § 23-2.1, the Board advised that it was unable to take further action regarding the resident's request and referred the resident to the applicable County Ethics Law provisions.

Administration

The Board held three (3) meetings during the current reporting period, which were conducted June 8, 2023, June 14, 2023, and November 6, 2023. Notice of all meetings, agendas, and approved minutes are available for public access and inspection on the Board's website. Copies of agendas and approved minutes are additionally attached hereto and made a part hereof.

The State Ethics Law requires each local ethics commission to certify to the State Ethics Commission that their respective county is in compliance with the provisions set forth in § 5-807 of the General Provisions Article of the Annotated Code of Maryland. As previously noted, revisions to the County Ethics Law are necessary to ensure compliance with the State Ethics Law. The Law Department has communicated the foregoing with the State Ethics Commission and as a result thereof, advised the Board to file the Annual Certification indicating legislative revisions to the County Ethics Law are forthcoming. The Board will then resubmit an Amended Annual Certification when County Ethics Law revisions are adopted by the County Council.

- **Discussion of need for closed session:**

- Jefferson Blomquist discussed the law and the requirements of when to move to closed session. Given this is not a personnel matter and the preference to remain transparent, there was no need to move for a closed session.
- All board members were agreement that we remain in open session.

- **Discussion of request for advisory opinion by Sarah Coleman:**

- Kirk Vollmecke, Chair, took the lead on reviewing Mr. Blomquist's request for an advisory opinion regarding Ms. Coleman's disclosure that she sits on the Environmental Advisory Board and the Parks and Recreation Boards and owns two companies that are doing business with the County. Ms. Coleman would like to bid on future stormwater and landscaping projects in Harford County and has requested an opinion on where or not a conflict of interest exists.
- Kirk reviewed the Harford County Code of Ethics, and the Maryland Ethics Commission policies along with the definitions of "Official" and "Conflicts of Interest" and any prohibition that may exist.
- Group discussions were had regarding any process for mitigation, recusal, standards of conduct and procurement procedures.
- Jefferson Blomquist indicated that he confirmed with the procurement department that Ms. Coleman currently has two businesses with contracts with HCG. Mr. Blomquist also reminded the group that Boards are advisory and do not make policy.
- Kirk pointed out that Ms. Coleman is an "Official" and they may need to consider when she was appointed to these Boards in relation to when she received contracts with HCG, and whether she disclosed owning two companies. Kirk stated that he is not sure that Ms. Coleman could actively participate on the Board and recuse herself. She would already have possible advance knowledge of information that could benefit her and/or her businesses during the procurement process.

- Discussions regarding possible exemptions under the Code that could be granted. No board members considered this to be a viable option.
- Jefferson Blomquist indicated that the Ethics Code is in the process of being amended, but there are no specific mitigation remedies.
- David Woods requested the names of Ms. Coleman's businesses. Jefferson Blomquist confirmed the business names based on his conversations with Procurement.
- Kirk is not sure how we can avoid the appearance of a Conflict of Interest when Ms. Coleman sits on these Boards. He is concerned and feels Ms. Coleman should resign from the Boards. Allyson and Dea agree with Kirk's recommendation.
- Dea asks if there is an appeal process for Ms. Coleman if we recommend that she be removed from the Boards. Jefferson confirmed that to his knowledge, there is no appeal process and not sure that any court would entertain an appeal because the Boards are advisory.
- Further discussions were held regarding members on other Boards and whether additional conflicts of interest exist. There should be a way to self-report or sign a statement after training to indicate no conflict of interest. Members feel that a recommendation should be made for other Boards regarding conflict of interest and self-reporting.
- Kirk indicated that the advisory opinion should be kept to the issue at hand for Ms. Coleman and then make other global recommendations, which could be taken to the County Council and/or County Executive.
- Kirk will draft an opinion and circulate for review by the Board members. Another meeting will be held to finalize and approve the advisory opinion.
- Deanne offered to prepare the minutes for circulation.
