Opposing overdevelopment

In January, County Councilman Aaron Penman introduced a [bill that would allow freestanding accessory dwelling units \(ADUs\) in all residential areas](#). I strongly oppose this bill because it would result in a massive increase in the density of housing in all areas of the county, negatively impacting the quality of life in existing communities, reducing property values, undermining effective zoning, and overcrowding schools. ADUs are currently allowed in Harford County but they must be within or attached to an existing single-family home and occupied by a relative of the homeowner. [Read my full statement here](#).



Veto for government spending mandate

I recently vetoed [County Council Bill 23-034 Hotel Tax](#) because it violates the County Charter and imposes a spending mandate on the executive branch of county government. Spending mandates are permitted by the Maryland General Assembly, but they were strongly criticized by former Gov. Larry Hogan for their negative impacts on the executive branch's ability to effectively manage government spending. AAA rating saves taxpayer money; bond proceeds help fund schools

Harford County retained our AAA bond-rating this year, placing us among the top 2% of counties nationwide for responsible fiscal management. This highest possible rating allowed us to sell \$40 million of new bonds at a low, 3.267% interest rate last month. The proceeds will help fund the new Homestead Wakefield Elementary School, renovations to Harford Technical High School, athletic field improvements, roads, bridges, and stormwater and wastewater projects. We also saved \$10 million over 10 years by refunding at a lower interest rate \$35.5 million in bonds originally issued in 2013 and 2014.



TAX CREDIT for qualifying seniors & veterans

Tax credit for qualifying seniors & veterans

Harford County's senior tax credit allows eligible seniors and veterans to receive a 20% credit on their county property taxes for the next fiscal year. To qualify, residents must be at least 65 years old; own a home in the county that is their primary residence with an assessed value of \$600,000 or less, and must meet one of the following conditions: They must have lived in their home for at least 35 consecutive years, or have retired from the U.S. uniformed services, or be the surviving spouse of a qualifying retired veteran. Disabled veterans of any age with a rating of at least 50%, or their surviving spouse, may also qualify. 
Veterans Corner - Housing assistance

Veterans who are at risk of, or experiencing, homelessness may qualify for up to one year of income-based rental assistance through our Department of Housing & Community Services. Veterans who are fleeing or attempting to flee domestic violence, dating violence, sexual assault, stalking, or human trafficking are also eligible. 
Minority & Small Business Resource Fair Feb. 15
