## High-tech assistance for school safety

Following the tragedy at Joppatowne, my administration met with the school superintendent and his security team to offer county assistance in securing our schools. We immediately moved to Joppatowne HS a high-tech security demonstration that had been scheduled to roll out at our emergency services facility in Hickory. That demonstration will help our school system evaluate firsthand some of the latest technology to assist in school safety. Harford County government will continue to support and collaborate with our schools as they work to keep our children safe.



## Impact fees reduce burden on taxpayers for expanding school capacity

New home construction naturally leads to increased student enrollment, which then requires additions to school capacity. Harford County charges impact fees on developers who profit from new homes, and the revenue is directed by law toward school expansion projects that would otherwise be funded entirely by taxpayers.

For too long Harford's impact fees have failed to reflect the true cost of school construction, unfairly adding to the taxpayers' burden. In response, my administration convened a workgroup and hired a consulting firm experienced in analyzing impact fees for counties in Maryland and nationally. Reflecting their recommendations, I have sent legislation to the County Council to ensure developers pay their fair share toward capacity projects such as the new Homestead Wakefield Elementary School and Harford Academy. I encourage the council to support this essential legislation.



## PFAS and safe drinking water

PFAS, or per- and polyfluoroalkyl substances, are a group of man-made chemicals used since the 1940s in consumer, commercial, and industrial products, and have been detected in water supplies throughout the nation. The EPA recently set limits on PFAS in drinking water as low as 4 parts per trillion and required public systems to test by 2027 and comply by 2029.

Customers of Harford's public water system can be assured that all recent testing shows PFAS safely below the EPA limits. 
## October "SOCKtober" donation drive benefits Harford's veterans, homeless


## Darlington Apple Festival Saturday, Oct. 5


## Maryland BBQ Bash Oct. 11 - 13


## Prescription Drug Take Back Day Oct. 26
