The [Water Infrastructure Financing Administration \(WIFA\)](#) is a unit within MDE that provides state and federal financial assistance in the form of low interest rate loans, loan forgiveness, and grant funding for eligible water quality, drinking water, and stormwater management capital projects.

Eligible types of projects include:

- Sanitary Sewer and Wastewater Treatment
- Drinking Water Infrastructure and Source Water Protection
- Nonpoint Source Pollution and Watershed Restoration
- Septic System Upgrades and Sewer Connections
- Stormwater Management and Flood Mitigation

Bipartisan Infrastructure Law Funding

- Includes 5 years of additional federal funding for the Water Quality and Drinking Water Revolving Loan Fund (RLF) Programs
- The BIL RLF funding is flowing to each state through their existing State Revolving Fund Programs using federal allocation formulas.
- MDE to receive more than \$800M in funding for local gvt projects over 5 years
- 5 buckets of funding
 - *Water Quality RLF – Supplemental Funding – all eligible uses – 49% loan forgiveness*
 - *Water Quality RLF – Emerging Contaminants/PFAS – 100% loan forgiveness*
 - *Drinking Water RLF – Supplemental Funding – all eligible uses – 49% loan forgiveness*
 - *Drinking Water RLF – Lead Service Line Replacement – 49% loan forgiveness*
 - *Drinking Water RLF – Emerging Contaminants/PFAS – 100% loan forgiveness*
- States are required to go through a public solicitation, scoring, and ranking process to allocate this funding – draft funding lists are then sent out for public comment and to EPA for review.

Bipartisan Infrastructure Law Funding (continued)

- Next solicitation open December 1 – January 31 is for the following FFY25 BIL funding:
 - Water Quality Revolving Loan Fund – Supplemental Funding = \$55M (49% LF)
 - Water Quality Revolving Loan Fund – Emerging Contaminants/PFAS = \$5M (100% LF)
 - Drinking Water Revolving Loan Fund – Supplemental Funding = \$44M (49% LF)
 - Drinking Water Revolving Loan Fund – Lead Service Line Replacement = \$30M (49% LF)
 - Drinking Water Revolving Loan Fund – Emerging Contaminants/PFAS = \$16M (100% LF)
- Draft funding lists to be released for public comment June 2025
- Funding available October 2025
